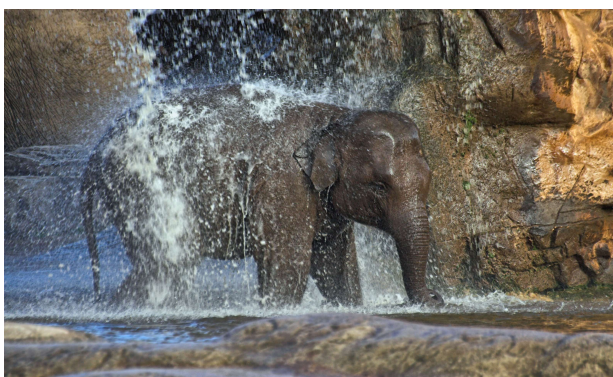

The Woman They Could Not Silence

*the shocking story of a woman who dared to fight back. Moore, Kate.
Naperville: Sourcebooks, 2021 (available DCL)*



Domestic violence did not begin in the 20th century, and abuse of power against women was worse in the 19th century than as depicted in the “me too” movement of recent years.

The author notes that her book is not about mental health but how it is used as a weapon. On June 18, 1860, Elizabeth Packard (1816-1897), the mother of six children, and wife of Presbyterian minister Theophilus Packard was escorted by train by her husband to the Illinois State Hospital in Jacksonville, and judged insane. There was no prior due process, much less a trial; many women like her were also incarcerated there. How did this happen? On a husband’s word, a wife could be judged insane, and Theophilus often threatened that to her to quiet her discourse. Notably, textbook examples of female insanity in the 19th century were: incessant talking, unusual jealousy, and a strong will. Families’ accounts of women’s personality traits were often used to make a diagnosis (57). Elizabeth’s husband surreptitiously had a physician engage her in topics of religion, for which he obviously noted her “unusual jealousy and prominent strong will” (ibid). (It should also be noted that Congress passed the Rights of Institutionalized Persons Act in 1972; before that, it only took one person (family) and a psychologist to admit someone to a mental hospital, per retired AWP NDOC Hubert.)

The Packards wed when she was 22 and he was 37. It was not a joyous marriage, but she managed a good household and took an active part in her children’s lives, whom she loved dearly.

As she became more intellectual, independent, and outspoken, her husband disapproved, and especially tried to sway church members against her. She enjoyed challenging him in religious debates, writing essays, and encouraging discussion in church classes, having studied other faiths and philosophies. Elizabeth also taught her children after church lessons, often making them laugh. Moore states she “easily eclipsed her husband without even trying.”

Additionally, she did not want to follow his new church’s doctrine, which was more conservative, and was ambivalent about abolition; she was for the freeing of slaves. Whenever she challenged his thinking, he dismissed her ideas as “the result of a diseased brain.” However, Elizabeth never believed she’d be in trouble as freedom of religion was a right in America.

Although the book is 537 pages, 433 is the actual text. The rest is epilogue, postscript, footnotes, photos, etc. The author somewhat lectures readers in her postscript not to call women crazy as was done to Nancy Pelosi, Martha Mitchell, Janice Dickinson, and Rose McGowan.) The book is a quick read, even though lengthy, and does not read like an academic textbook. The author is meticulous in her research and narrative of events pertaining to Elizabeth’s life. For instance, in outlining the 1848 first Women’s Rights Convention in Seneca Falls, New York, Elizabeth’s husband parallels her independence as an outgrowth of newly outspoken women there, nationally described as “fugitive lunatics.”

Other women inmates in the asylum become Elizabeth’s friends or helpers in her cause for better treatment and freedom. Time in the insane asylum depicts many diverse women (put there by husbands) who suffer intensely, miss their children immeasurably, and are often treated with violence and disdain. Elizabeth is optimistic at first and gathers hope when meeting her intellectual equal, Dr. Andrew McFarland, the magnetic personality who runs the institution. She falsely believes that he is helping her gain a quick release back to her children.

However, she never gives up; months turn into years, delayed by the Civil War, which hinders even simple acts of letter mailing and delivery. Most importantly, Elizabeth Packard overcomes her tribulations, incarceration, and a bad marriage. She redeems herself and rebuilds her reputation and becomes a famous advocate for women, without submitting to easy compromises, lasting defeat, or bitterness.

Spotlight on Nancy Brisack

Nancy (pictured) has been a longstanding SNRW member, and her husband, Phil (also pictured), is an associate member. Nancy was featured in an article in our newsletter a few years ago. Below is an update from Nancy.

SIERRA NEVADA REPUBLICAN WOMEN

May 11, 2022 Luncheon Meeting , C.O.D. Casino, Minden, Nevada

Call to order: The May meeting of SNRW was called to order at 11:49 a.m., Wednesday, May 11, 2022, by the President, Sondra Condon, at the C.O.D. Casino in Minden, NV.

She welcomed everyone and reminded members to silence their phones. The prayer was given by member Charlene Close, followed by the salute to our great flag by Jim McKalip.

Introductions: President Condon recognized attending dignitaries: Senator James Settelmeyer, Assemblyman Jim Wheeler, Assemblywoman Robin Titus, Douglas County Commissioner Mark Gardner; Gardnerville Ranchos General Improvement District Trustee and Chair of the Douglas County Republican Central Committee Jim McKalip, Clerk-Treasurer Amy Burgans, and Commissioner Danny Tarkanian.

Program: First Vice President Sharla Hales introduced the candidates for State Senate District 17 Assemblywoman Robin Titus and Assemblyman Jim Wheeler and gave the background of each. She explained the debate process and rules, and she then moderated the debate between the two candidates, followed by questions from the floor. She acknowledged timekeeper Pat Smith. A copy of the rules and questions are attached to the original Minutes.

VP Hales stated that the program for the June 8 meeting would be another debate with the Commissioner Candidates for District 4.

Vice President-Membership: Second Vice President Barb

McRoberts reported 75 current members and 57 associates, plus one new associate and one new member as of today's meeting. The several guests attending the meeting today were welcomed and asked to stand to be recognized. She noted that she sent out a copy of the membership roster and asked all members/associates to review the information and let her know of any changes. She mentioned that name badges are \$20.00 and asked anyone interested to contact her.

Treasurer: Treasurer Jacie Peters had to leave the meeting early, so President Condon gave the Treasurer's report (copy on file for audit) in her absence. She reminded members that SNRW is a P.A.C. and raises money for contributions to candidates during the general election. She noted that \$16,500 is in the budget for distribution this year (and we may be able to give more) and asked members to contact her or any member of the Executive Board with a suggestion of candidates in need of additional funds.

Minutes: President Condon asked for approval of the April Minutes. M.S.C. that the Minutes of the April 13, 2022 meeting be approved as distributed through The Rumbler.

New Business: President Condon reported on the following: Carson Valley Days Parade will be on June 11. The Central Committee will have a float again this year. Anyone interested in helping or who would like to ride on the float is

asked to contact Sondra.

SNRW Tri-Fold Brochure needs to be updated. Sondra asked for a volunteer to head this project. Anyone interested should contact her.

Pat Smith has agreed to Chair the Nominating Committee. If anyone would like to be on the committee, please contact Pat Smith.

Sample ballots for the Primary have been sent out. Amy Burgans commented that on the front of the sample ballot by your name, it shows how you are registered. If it doesn't state Republican, let her office know. If it shows Independent and you want to change it, it can be done up to the election time.

Announcements: Items for the next edition of The Rumbler are due to Anita Kornoff by May 25.

SNRW, DCRW, and Incline Village Republican Women's Clubs will host a Governor Candidates Forum on May 14, 2022 (3-6 p.m.) at the Valley Christian Fellowship. Eight candidates have agreed to attend, and it is expected more will be coming.

The next two Executive Board meetings have been changed in date/time because of holiday conflicts. The next two meetings will be June 1 from 4:00-5:30 and July 6 from 4:00 to 5:30 at the Republican Headquarters in Gardnerville. Members are always welcome to attend.

DCRCC: Jim McKalip, Chair of the Douglas County Republican Central Committee, reported the Central Committee is recruiting Poll Watchers. There will be meetings

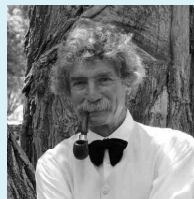

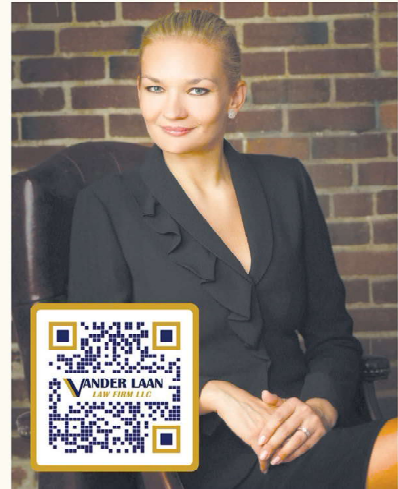
