to help.

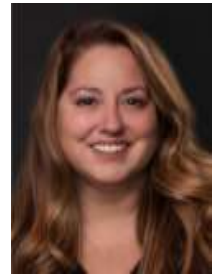



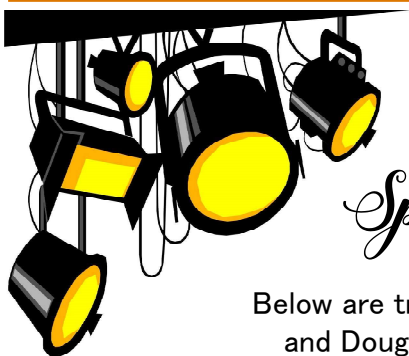

# MINUTES

## SIERRA NEVADA REPUBLICAN WOMEN

### September 14, 2022 Luncheon Meeting , C.O.D. Casino, Minden, Nevada

**Call to order:** The regularly scheduled meeting of SNRW was called to order at 11:56 a.m., Wednesday, September 14, 2022 by the President, Sondra Condron at the C.O.D. Casino in Minden, NV. She welcomed everyone and reminded members to silence their phones. The prayer was given by Associate Member Lynn Muzzy, followed by the salute to our great flag led by Jim McKalip, Chairman of the Douglas County Republican Central Committee.

**Introductions:** President Condron recognized attending dignitaries: Commissioner Chair Mark Gardner; Clerk-Treasurer Amy Burgans; Jim McKalip, Chairman of the Douglas County Republican Central Committee; Sharla Hales, Douglas County Commissioner Elect; Brenda Robertson, President, Douglas County Republican Women; Garrett Tamagni, Election Integrity Director; and Nicol Herris, 2nd Vice President of the Nevada Federation of Republican Women and Moderator for today's meeting.

**Program:** First Vice President Sharla Hales commented that much time, thought and effort went into planning this meeting. She, Jan Muzzy and the Board worked hard to develop the format and questions for the six candidates for School Board. Every effort was made to insure questions were respectful and transparent. She then introduced the moderator, 2nd VP for NVFRW, who then reviewed the process of the debate. She introduced the six school board candidates: District 2 – Robbe Lehmann

and Susan Jansen; District 6 – Katherine Dickerson and Heather Jackson; and District 7 – David Burns and Roberta Butterfield.

Nicol stated she was honored to be asked to moderate this very important debate and commended the Board for their gentle and professional manner in which this program was managed. She reviewed the format and noted that because of time constraint, there would be no time for questions from the audience. Ms. Herris and the candidates were thanked for the extremely informative and dignified program. A copy of the script, format and questions is attached to the original Minutes. Vice President Hales reported that the speaker for the next meeting will be Sigal Chattah, candidate for Attorney General. **Vice President-**

**Membership:** 2nd Vice President Jacie Peters reported that there were 33 guests attending today's meeting and welcomed them all and encouraged them to join SNRW. Currently there are 81 members and 62 associates in SNRW. Ms. Peters reported the Welcome Brunch for new members was well attended and all had a good time. There was a small gathering for a recruitment reception last week at COD Casino.

**Treasurer:** Treasurer Jacie Peters reported on the current bank balance, noting that after distribution of \$21,500 to candidates, there is still sufficient funding for expenses for the remainder of the year.

**Minutes:** President Condron asked for approval of the August 10 Minutes. There being no corrections to the Minutes of the August 10, 2022 meeting as printed in The Rumbler were approved.

**Election Integrity:** Sondra Condron introduced Garrett Tamagni, Northern Election Integrity Director for the Republican Party of Nevada. Mr. Tamagni discussed how members of SNRW can help him help and the State. He referred to the election in Virginia last year where the Republicans overcame all odds and a Republican Governor was elected. The same thing could happen here. He urged members to sign up for training to be a poll watcher in the upcoming elections, as well as work phone banks, walk precincts and in general support the election process. Ms. Herris noted that recently the Nevada Federation of Republican Women (19 clubs) won the national 1st place award for campaign hours, with in excess of 330,000 hours of phone calls on behalf of Republican candidates. She urged the members to keep up the good work.

**New Business:** President Condron reported on the following: Alice Garcia is the club Chaplain and in charge of arranging the opening prayer at the meetings. She asked for volunteers to contact her if they would be interested in giving a prayer at one of the meetings.

The proposed Bylaw amendments were distributed to all members via email for voting. A quorum was received in favor of the amend-

ments, which was ratified by the Executive Board at their last meeting. She thanked all who responded to the vote.

- DCRW is having their fall fundraiser, Fall Frolic 1860's Style, on October 14th at the Community Center. All are invited.
- Poll-Watch training will be at the Headquarters on September 27th, 1:30 p.m.

**Adjournment:** There being no further business, the meeting was adjourned at 1:15 p.m.

This year the CCRW will hold its annual Nevada Day Pancake Breakfast on Saturday, October 29, from 7 to 9:30 a.m., and the public is invited.

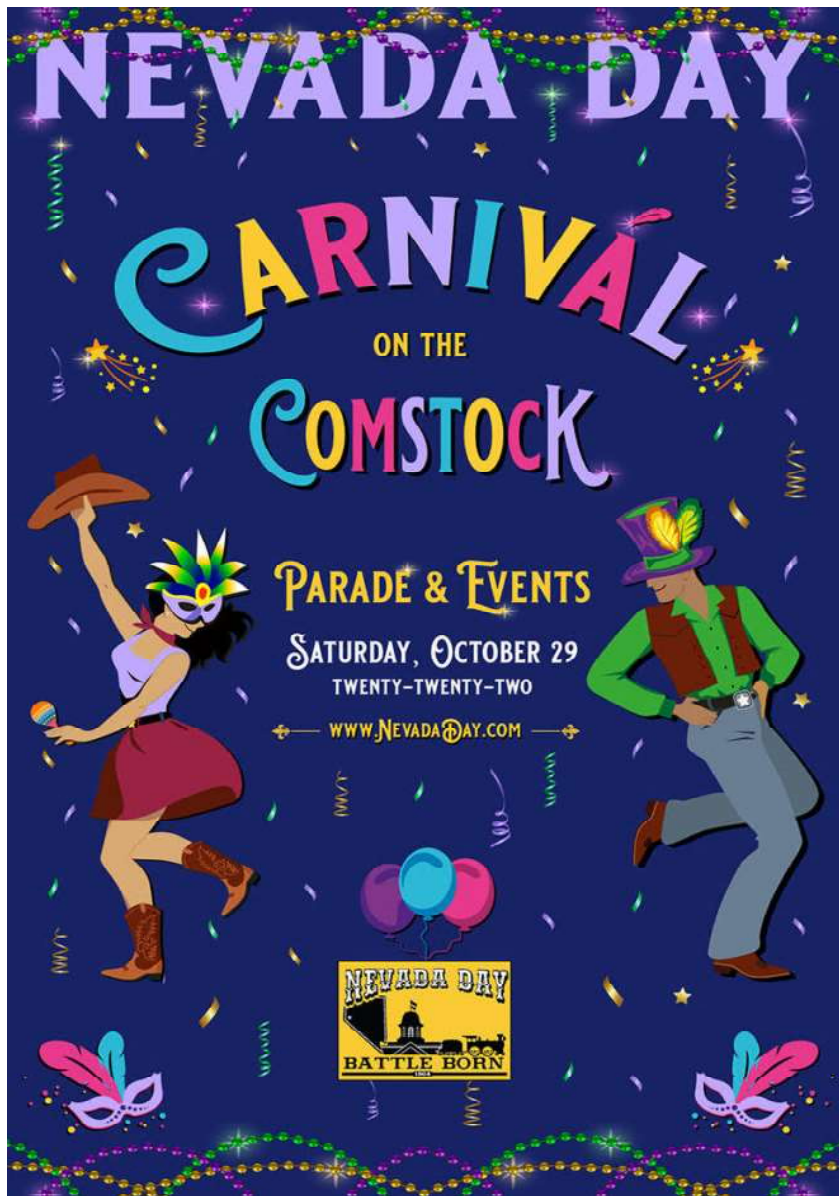

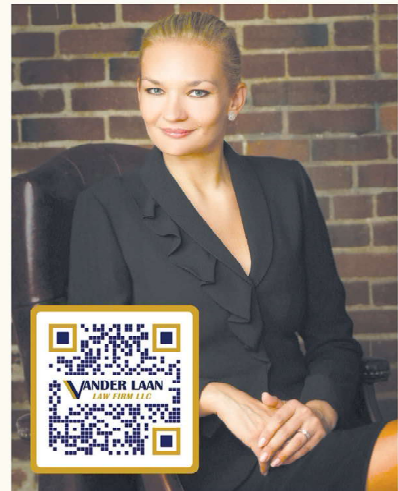
