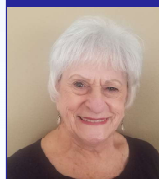

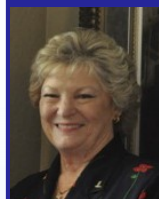

Applications are being accepted from August 1 through October 15, 2022. The Award is presented at the November regular SNRW business meeting.

## Who do you know?

SNRW Entrepreneur of the Year candidates are all around you. Be aware and brave enough to ask, "are you the owner of this business? If she is an independent contractor, she participates with others in the same business but oversees her own actions and success; she qualifies. Ask, "Are you an Independent Contractor working alongside others."

Compliment what you see as her skills and tell her that you are a member of SNRW and would like to nominate her. Would she be interested? Ask if she is a registered Republican? If not, ask if she would consider registering, and then you could nominate her for Entrepreneur of the Year. Tell her that all nominees are featured in our SNRW newsletter and press releases and invited to the Awards meeting in November. Here is an excellent opportunity to network with other business professionals. Offer to meet with her to help her complete the Nomination Form.

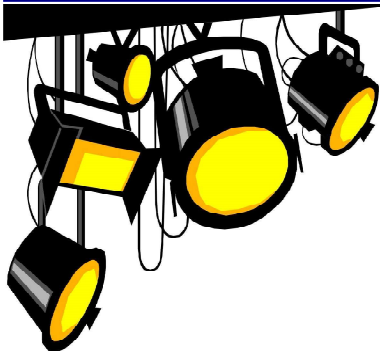

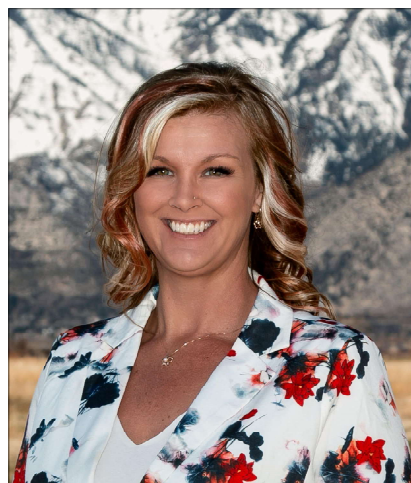
# Amy Burgans

Volunteering has always been a large part of my life from the time I was very young. I was raised to have a servant's heart and understand the importance of filling needs within the community. When I was very young, about 11, I started volunteering in the nursery at church. Babies and toddlers were a love of mine from a very young age. Looking back, now that I have five children of my own, I can see how this was a blessing to the young mothers that wanted to sit in church for just a couple of minutes of peace, knowing that their children were taken care of and loved. I still remember the babies that I held, the toddlers that I played with, and the parents that came back to get their children after a much-needed break.

As I got a bit older, I developed a passion for health care. I started volunteering at my local hospital as a candy striper at 14 years old. I did this for four years, all through High School. I worked in many of the departments at the hospital, from helping the sick and elderly to cleaning medical instruments to prepare them to be used in surgery. Due to the amount of hours I volunteered over those four years, I earned a scholarship to nursing school, though by the time I graduated high school, I had decided to go another path.

Volunteering to join the military was a bit selfish, as I wanted to leave home and see the world while serving my Country. At the time I could never have imagined how greatly this decision would affect my entire life in so many profound ways.

In 2001, when my oldest son was three, the church I attended back East started an AWANA club. This is a church-based group for children ages 3-18 where children learn Bible verses, play games, and earn awards for their participation. I stayed a leader with AWANA for 19 years, raising all five of my kids in the program. When my older children got to their Jr. High and High School years, they also became stu-



dent leaders using their talents to help with the younger children. During these years, I relocated from the East Coast, where I was stationed in the Army, to Nevada. Over the last 16 years, I've assisted in starting multiple AWANA programs here in the Carson Valley.

Raising five kids means a lot of extracurricular activities. Soccer has always been a huge part of my children's upbringing, which led to volunteering as a soccer mom, coach, referee, and any other positions needed to keep AYSO going so the kids could play soccer. While homeschooling my kids, we were always a part of the local co-op, where I taught classes and participated in organizing events.

I have found through my many years of volunteering that I typically walk away blessed from the experience as much as those that I am serving. Being a part of something bigger than me and helping to make the world a better place, even in a small way, leads to fulfillment and satisfaction that only comes from having a willing heart and servant's hands.

# Campaign Volunteer Hours Update

It's time to report your Volunteer Campaign Hours. Mary Lou Gervie, our Campaign Chair, keeps track of our Volunteer Campaign Hours. Mary Lou messaged each of us in April, asking that we compile our Volunteer Campaign Hours between July 1, 2021, and June 30, 2022, and send them to her. She also sent us a copy of the NFRW Policy for Counting Volunteer Hours. After doing this, we learned that NFRW had enlarged the activities that can be counted. The purpose was to include all legitimate *political* activity that benefits our party.

There are four significant changes, YOU CAN COUNT:

- (1) All time spent attending or preparing for Club meetings and DCRCC meetings. Include your travel time to and from these meetings.
- (2) Attendance at All Republican Events, even if you purchased a ticket to attend a fundraiser. *Lincoln-Reagan Dinner, St. Patrick's Dinner, Heritage Fundraiser.*
- (3) Working as a Poll Worker, Election Officer, Clerk, Challenger, or Election Integrity Worker even if you are paid.
- (4) All campaign activities benefitting the Federation, the Republican Party, or Republican Candidates. (This is a major change to item #1 on the earlier list, which limits the hours that count to all *non-paid campaign activities*.)

In short, you can accumulate hours for working on any aspect of a Republican campaign, partisan or non-partisan. Some activities that you may be overlooking include getting out notification of candidate campaign events, preparing letters to the editor, and working on ballot questions, initiatives or petitions.

For hours from last July to the end of June,

you can report the total hours per month with a short description. Some of you who have A LOT of hours to report can give Mary Lou a call, and she will work with you to simplify. Mary Lou set a deadline of July 5. You may call her or call me if you have questions.

Mary Lou has asked that your time spent making political and campaign calls be reported to her separately because they must be reported to NFRW separately.

Why report hours? Your hours have value! According to NFRW, each hour is valued at about \$30, and that was before the increase in gas prices. You deserve to be recognized for your hours and work!

# MINUTES

## SIERRA NEVADA REPUBLICAN WOMEN

### June 8, 2022 Luncheon Meeting , C.O.D. Casino, Minden, Nevada

#### Call to Order:

The June meeting of SNRW was called to order at 11:53 a.m., Wednesday, June 8, 2022 by the President, Sondra Condon, at the C.O.D. Casino in Minden, NV. She welcomed everyone and reminded members to silence their phones. The prayer was given by Kathryn Zogorski, followed by the salute to the flag led by Commissioner Mark Gardner. Introductions: President Condon introduced attending dignitaries, including Commissioners Mark Gardner and Wes Rice; DCRCC President and Gardnerville Ranchos General Improvement District Trustee Jim McKalip; Tahoe District Trustee Janet Murphy; Minden Gardnerville Sanitation District Board Chair Barbara Smallwood; Natalie Yanish, Trustee Kingsbury General Improvement District; and Former United States Ambassador to Germany and Acting Director of National Intelligence, Rick Grenell.

#### Program:

Mary Porter introduced the candidates for County Commissioner, District 4, including Wes Rice, Janet Murphy, and Natalie Yanish and gave brief biographical information for each of them. She explained the debate process and rules, and she then moderated the debate between the three candidates. She acknowledged time-keeper Pat Smith and assistance with questions by First Vice President Sharla Hales. VP Hales announced the June program: Nevada Federation of Republican

Women president Caroline Smith will speak briefly, followed by Clerk-Treasurer Amy Burgans, presenting information about the recent primary elections. Vice President-Membership: Second Vice President Barb McRoberts reported 78 regular members and 58 associates, including two new members and one new associate member, whom she welcomed. VP McRoberts informed the group that name badges are available for \$20 and take about one month to get. She also mentioned that emails to members with Charter email addresses are not working properly and come back undeliverable.

#### Treasurer:

Treasurer Jacie Peters reported the current bank balance and amount available for donations to candidates. She stressed the importance of RSVPs as there were 14 walk-in attendees (27%). With so many more than planned on, it is difficult to prepare adequately.

#### Minutes:

Jacie Peters moved approval of the May 11, 2022 minutes, with Barbara McRoberts seconding the motion, which passed unanimously. New Business: On behalf of Mary Lou Gervie, Mary Porter requested that all members submit "volunteer hours worked between July 2021 through June 2022. Mary reported that the list of qualifying activities has been revised, becoming much broader. She requested everyone go

through their calendars and prepare a list of activities with a total number of hours to submit to Mary Lou. The deadline to submit is July 15, so members should have their information to Mary Lou by July 5. Because each hour represents \$30 worth of work, it's important to submit.

#### Announcements:

President Condon announced that the next Rumbler deadline is June 25, and the next board meeting will be July 6. President Condon invited candidates to introduce themselves and announce the office they are seeking.

President Condon wished all of the fathers in attendance a Happy Father's Day and wished all a Happy 4th of July.

#### Adjournment:

There being no further business, the meeting was adjourned at 1:05 p.m.

## *Rebel with a Cause: The True Story of Jerry Tarkanian*

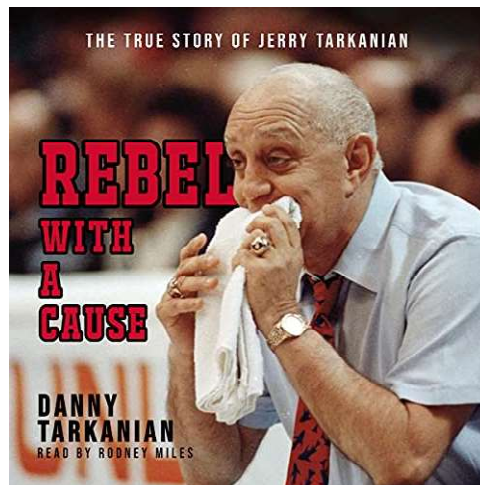
Like many of you, I found this primary season to have been a busy one. After votes were counted I had time to relax, and picked up a book I had been lucky enough to find on the silent auction table at our St Patrick's Dinner---"Rebel with a Cause, the True Story of Jerry Tarkanian," by Danny Tarkanian. It is a well written, very interesting book that both sports fans and those that are not sports fans will enjoy.

If you are a sports fan the book undoubtedly will hold your attention. Jerry Tarkanian was one of the best, if not the best defensive coach in college basketball, as is stated by Coach Mike Krzyzewski in the book's Forward. You will learn about players who were recruited and coached by Jerry Tarkanian, some of whom subsequently became NBA players—George Trapp, Stacey Augmon, Ed Ratleff, Reggie Theus, Armen Gilliam, Larry Johnson, Melvin Ely and others. The relationship Coach Tarkanian built with his players and adaptations to their talents are well described.

If you are not a sports fan, or as avid a sports fan as I am, your attention will be held by the author's detailed account of the NCAA's accusations against and treatment of Coach Tarkanian, the three universities at which he coached, and some of his players. Coach Tarkanian challenged an unfair and powerful bureaucracy.

He withstood this unfair treatment for over 25 years while providing motivated young men, primarily from the inner cities, the opportunity to attend college when other coaches would not have recruited them, or even scouted them. Ultimately Coach Tarkanian was vindicated when the NCAA paid him 2.5 million dollars to settle the case he had filed against the organization.

Since Jerry Tarkanian was the basketball coach at Cal State Long Beach when I was a student there, the book had additional appeal for me. I recalled very vividly some of the episodes the author described—the game with Marquette, when Coach Al McGuire



brought his Warriors to play my Cal State Long Beach 49ers. What a game! And there were so many others. And what Nevadan (or any basketball fan) could forget the 1990 NCAA championship game when Tarkanian's Runnin' Rebels defeated the Duke Blue Devils. What a game!

Readers will understand the author's pride in describing the life, challenges and successes of his father, the coach. The final chapter, however, is written by

Jerry Tarkanian's wife, Lois, documenting Jerry's induction into the Hall of Fame. She relates that his induction brought to mind having met Jerry 58 years earlier; he was a first generation Armenian-American college student, who wanted to be a coach.

## Election Workers

I had the privilege of working for Amy Burgans, Clerk Treasurer of Douglas County as an Election Worker for the Douglas County Primary Elections. Election workers perform valuable community service and are essential to ensuring the conduct of elections is accurate and fair. Amy and her staff ran a tight ship to ensure the collection and processing of mail-in ballots were transparent and authentic. The same was true for electronic voting machines.

Election workers performed multiple tasks under the supervision of Douglas County employees. They verified voter registration, assisted with the operation of the voting machines, guarded the drop boxes, and processed the mail-in ballots. Anyone on YouTube could view the processing of mail-in ballots for transparency. After assisting with the processing of mail-in ballots, I believe that mailing ballots to every registered voter is not only costly but labor intense. **We need to return to safe electronic voting by early and election day voting.** That must be changed by legislation. Nevertheless, I want to thank Amy and her staff for a carefully planned and executed election process.

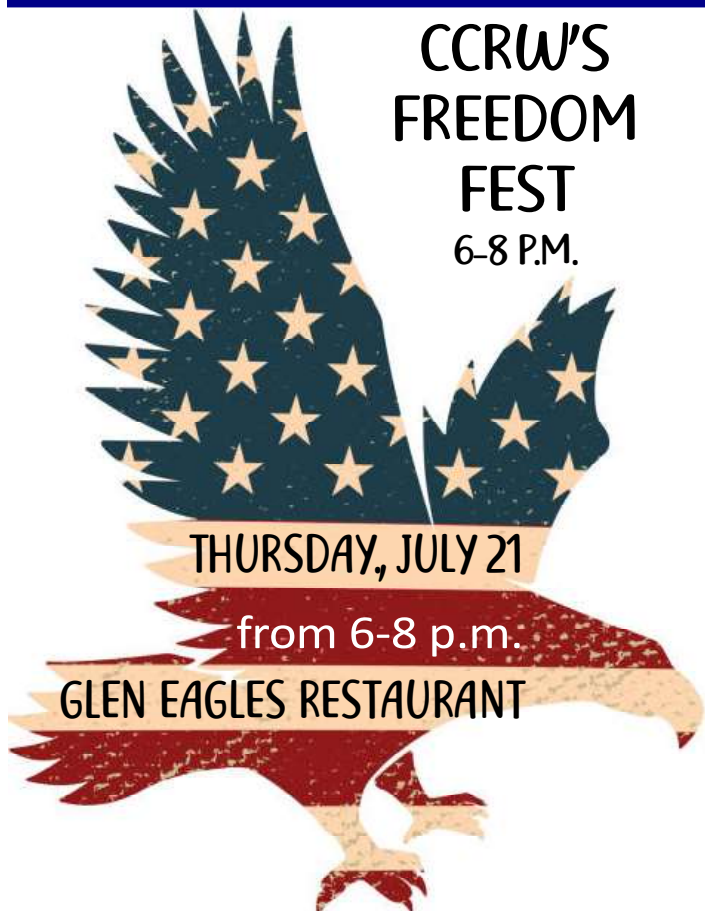

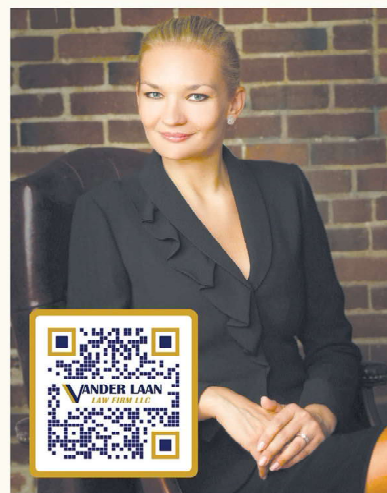
