



## REVIEW: *THE STRANGER IN THE LIFEBOAT,* A NOVEL BY ALBOM, MITCH.

NYC: HARPERCOLLINS, 2021 (AVAILABLE DCL)



If you've ever been angry at yourself or God, this book could give some comfort.

Notice that I did not say "will." Is it a selfhelp book? (Most selfhelp books are nonfiction.) Perhaps. "But, remember, comfort does not last, nor does difficulty.

The author is not

preachy but leads the reader on a voyage filled with lifeboat survivors. The pace quickens when they pull a stranger into their boat. A woman says: "Well, thank the Lord we found you." "I am the Lord he whispered" (5). Of course, some passengers overanalyze the stranger, who often speaks in aphorisms: "Worry is something you create." Nina asks: "Why would we create worry?" "To fill a void." "A void of what?" "Faith" (96).

We tell ourselves stories to survive; to gain an understanding of ourselves and others. Or to be entertained, or educated, or merely to change our moods. Albom (and the Lord) give answers that the survivors don't want to hear, don't understand, or even want to think about. (Welcome to life.) Fortunately, the aphorisms never overpower the story; i.e., we truly want them to survive until tomorrow. However, words can show peaceful and loving resolutions: "She said it was time to trust God...then she smiled, and her eyes closed" (66).

Need...not phony Facebook posts or dutiful emails or tiresome texts. "What we yearn for most is comfort. A soft embrace. Someone to whisper. It's all right. It's all right" (135). Those words are why we miss the person who first said them to us, and whom we unhesitatingly believed. And, we continue to say these words to others and to believe them just because.

#### SIERRA NEVADA REPUBLICAN WOMEN MINUTES

February 9, 2022 Luncheon Meeting C.O.D. Casino, Minden, NV

Call to order: The February meeting of the SNRW was called to order at 11:47 a.m., Wednesday, February 9, 2022 by the President, Sondra Condron, at the C.O.D. Casino in Minden, NV. She welcomed everyone and reminded members to silence their phones. The prayer was given by member Pat Smith, followed by the salute to our great flag by County Assessor Trent Tholen.

#### Introductions:

President Condron recognized attending political leaders: County Assessor Trent Tholen; Assemblywoman, District 26 Lisa Krasner; Douglas County Commissioner Mark Gardner; Jim McKalip, Gardnerville Ranchos General Improvement District Trustee and Chair of the Douglas County Republican Central Committee; Tony Magnotta, Douglas County School Board Trustee.

#### **Guest Speaker:**

Vice President Sharla Hales, after giving an impressive background and qualifications to be today's speaker, introduced Jim Hartman. She noted that he was uniquely qualified to discuss the republican candidates for governor. Mr. Hartman began by describing the political makeup of Nevada for the past sixty years. He noted that 60 years ago, Minden had a population of 500 and the Capitol (Carson City) had about 5,000. The current composition of Nevada right now is 34% Democrat, 30% Republican, and 28% other/decline to state. He then discussed each of the nine candidates vying to unseat Governor Sisolak, discussing the financial backing for each. His prediction of electability at this time based somewhat on financial support (last to first) Barak Zilberberg, Tom Heck, Guy Nohra, Fred Simons, John Lee, Joey Gilbert, Michele Fiori, Dean Heller and Joe Lombardo. He emphasized the importance of defeating the current Governor and felt optimistic it can be done.

#### Vice President-Program:

Sharla Hales, after extending the thanks of SNRW to Mr. Hartman, stated the planned programs for the next few months will be: March – St. Patrick's Fundraiser Dinner; April - Candidates for State Assembly; May – Candidates for School Board; and June – Candidates for State Senator.

#### Vice President-Membership:

President Condron, in the absence of Membership Chair Barbara McRoberts, reported that as of today we have 56 members and 45 Associates. The several guests attending the luncheon today were welcomed and asked to stand to be recognized. She reminded members that 2022 dues are due now. Badges are \$20.00. She noted that a quorum was present.

#### Treasurer:

Treasurer Jacie Peters reported on the financial status of the club, noting it is in very good shape. Treasurer Peters then stated that the Executive Board met, reviewed and approved the proposed 2022 budget which was distributed to the membership via email and at the last meeting. She has received no comments from membership since the distribution. She explained the budget process and specifically noted that it is anticipated that SNRW will be able to distribute at least \$16,000 to Republican candidates in upcoming State elections. After review and discussion, it was MSC (Muzzy/P.Smith) that the 2022 SNRW Budget be approved as distributed.

Several members have paid an annual luncheon fee, and Jacie has made special place mats for those members. There is still time to pay in advance, thus, not having to pay the \$5 each month. She again reminded everyone to be sure and RSVP for the luncheons.

#### St. Patrick's Dinner:

Treasurer/Chair-St. Patrick's Dinner Jacie reported that the St. Patrick's Dinner will be on Sunday, March 13th and will be at the Carson Valley Inn. She commented she is not asking for every to come and cook the food, set up and decorate the hall, clean up, etc. as in the past, but she did ask for help in buying and selling tickets. Tickets are \$45.00 and she urged everyone to attend and invite others. She is also looking for items to be included in the silent/live auctions. Please contact Jacie, Pat Smith or Sally Grant. This is the only major fundraiser that SNRW does, and the funds go toward supporting our republican candidates.

#### Minutes:

MSC (O'Berg/Muzzy) that the Minutes of the January 12, 2022 meeting be approved as distributed in The Rumbler.

#### **New Business:**

President Condron reported on the following: NvFRW has asked each club to nominate a delegate and two alternates to be on the NvFRW's Nominating Committee. President Sondra asked for volunteers from the membership.

MSC (Muzzy/Jarvis) that Sondra Condron be a delegate and Jacie Peters be an alternate to the NvFRW

#### Nominating Committee.

SNRW, DCRW, and Incline Village Republican Women's Clubs are hosting a Governor Candidates Forum on May 14, 2022 (2:00-4:00) at the Valley Christian Center. Several candidates have already agreed to attend. Watch for further announcements.

President Condron and DCRW President Robertson met with the County Clerk-Treasurer. There is a big need for election workers and she reviewed the process to volunteer. She urged members to volunteer. More information will be sent out later.

The County Convention and Precinct meetings are being combined this year and will be held on March 12th at Valley Christian Center.

The NvFRW Board Meeting will be held in Reno on April 9th. All members are invited to attend.

#### **Announcements:**

President Condron announced that the Board decided that there will not be a 9/11 Dinner this year. The memorial dinners will be held every five years. Last year was the 20th anniversary and the next dinner will be held on the 25th anniversary. There will be a recognition 9/11 luncheon at our regular meeting in September. Items for the next edition of The Rumbler are due to Anita Kornoff by February 25th.

#### **WAVE Presentation.**

President Sondra introduced Carl Schnock, President of WAVE (Welcome All Vets Everywhere, Inc.). SNRW has been supporting WAVE by passing a "can" during our luncheons. Mr. Schnock gave a very moving talk about how WAVE helps meet the needs of our veterans in Douglas County and told stories of some of our veterans who have been helped. He thanked SNRW for its continued support. 100% of funds collected go to veterans; there are no paid employees. President Sondra report ed that SNRW collected \$145 from today's luncheon for WAVE.



For example, you could post flyers, share information on social media and show your support for the elephant through events and fundraisers.

There are plenty of ways to help raise funds for elephant conservation. How about a themed bake sale or a 'pin the tail on the elephant' contest? Why not try auctioning off some elephant artwork or other memorabilia? Or, you could organize an 'elephant walk' and compete to see who can plod their way the farthest. Whatever you do to celebrate, be sure to share this important day with your club members, friends, family neighbors, and colleagues and help save the elephants together!
