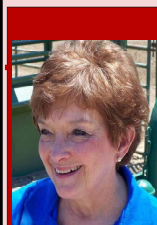

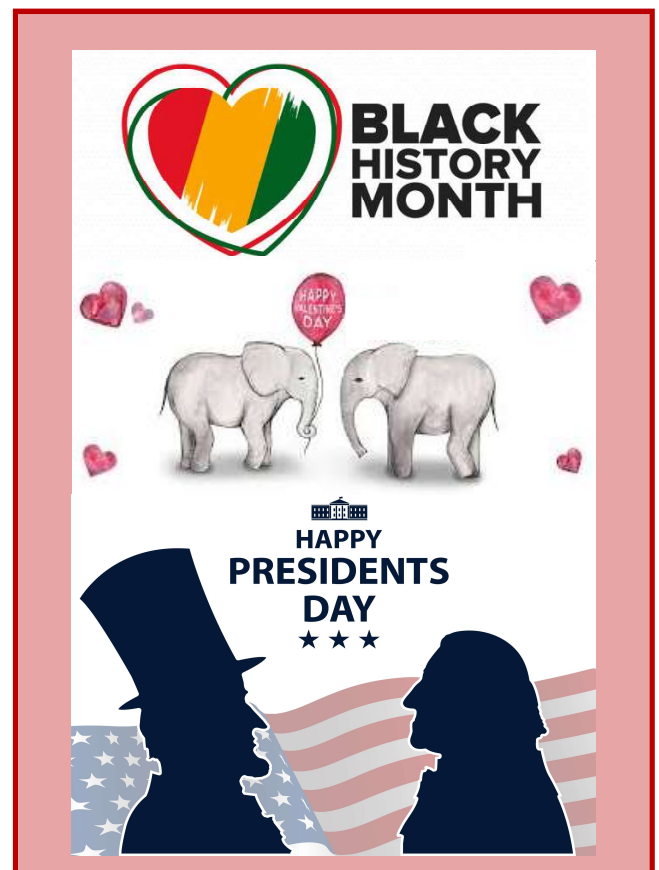
Support your Club—and save time!

Introducing our New Recording Secretary Nancy Jarvis

I worked for 35 years as Corporate Secretary and Administration Office Manager at Children's Hospital of Los Angeles (CHLA). A wonderful job for 30+ of those years. I had 13 different “bosses” while there (CEOs and Board Chairs), so my job description changed often. A large part of my position as Corporate Secretary was taking Minutes at the Board meetings, as well as eight Board committees. So, hopefully, I am somewhat qualified to take Minutes at SNRW. Recommended Reading

I have a reading recommendation in keeping with our upcoming President's Day holiday. Although David McCullough's "John Adams" and Doris Kearns Goodwin's "Team of Rivals"

would be wonderful recommendations, mine deals with the biography of a president about whom not as much has been written.

I have enjoyed reading and am recommending *Polk, the Man who Transformed the Presidency and America*, by Walter R. Borneman, Random House, 2008. The book is available at our Douglas County Public Library. It is well researched and well written.

James K. Polk was our 11th President. Borneman describes how Polk had become an accomplished Tennessee politician and served seven terms as a U.S. Congressman from Tennessee before his presidential nomination and election, even though he was twice defeated in runs for Tennessee governor.

Polk was President from 1845 to 1849. His was a very consequential single term that saw the territorial borders of the United States expand with the additions of Texas, Oregon, California, and much of the Southwest.

Borneman's book takes note of Polk's personal flaws as well as his relationships and rivalries with several interesting, significant historical figures including his primary mentor, Andrew Jackson, Henry Clay, who avidly sought the presidency, and Zachary Taylor who followed Polk as president. The author describes Tennessee politics in the 1840s as "bloodspot." (Sound familiar?)

Since Polk held office in the shadows of Presidents Jackson and Lincoln about whom much has been written Polk's presidential term has not received much literary attention. Borneman is a well known historical writer, and this biography has been welcomed by scholars.

If you are interested in American history, you will enjoy this book. I look forward to receiving your reading recommendations.

Democrat Platform vs Republican Platform

SIERRA NEVADA REPUBLICAN WOMEN MINUTES January 12, 2022 Lunch Meeting | C.O.D. Casino, Minden

Call to order: The January meeting of the SNRW was called to order at 11:47 a.m., Wednesday, January 12, 2022, by the President, Sondra Condrón. She welcomed everyone and reminded members to silence their phones. “The prayer was given by member Janice Kriss, followed by the salute to our great flag by Assemblyman Jim Wheeler.

Introductions: President Condrón recognized attending political leaders: State Assemblyman Jim Wheeler; County Assessor Trent Tholen; Sheriff Dan Coverley; Douglas County Commissioner Mark Gardner; Lyon County Commissioner Ken Gray; Jim McKalip, Gardnerville Ranchos General Improvement District Trustee and Chair of the Douglas County Republican Central Committee; Tony Magnotta, Douglas County School Board Trustee; Brenda Robertson, President, Douglas County Republican Women.

Guest Speaker – Sheriff Dan Coverley: In the absence of 1st Vice President Sharla Hales, President Condrón asked the wife of the guest speaker to introduce her husband. Sarah Coverley gave a very warm, personal, and sometimes humorous description of our Sheriff, a true local native of Douglas County. Sheriff Coverley gave a very detailed description of the activities and issues of the Douglas County Sheriff’s office. He noted a recent upward trend of violent crime nationally, which is beginning to be seen in Douglas County. The change over the last two years in the judicial/court system has caused this increase; many crimes have been decriminalized and penalties lessened. Without penalties, or deterrents, crime increases and the safety to citizens decreases.

It is his intent to continue to protect the community; to take care of the little things to decrease big crimes from happening. His officers travel throughout the County for the protection of the citizens; they are very proactive in stopping all crime. He emphasized that if you call for a deputy for any reason, you will get a deputy. He highlighted the various programs within the department, noting that service to the community is priority in all areas. After a question/answer period, the Sheriff received a thunderous round of applause.

Vice President-Program: President Condrón reported for Vice President Hales that the speaker for the February meeting will be Jim Hartman who will be discussing the 2022 Governor’s race and review the Governor’s candidate field.

Vice President-Membership: Barb McRoberts reported that as of today we have 45 members and 36 Associates. There were 29 guests attending the luncheon today and she welcomed them and had them stand to be recognized. She reminded members that 2022 dues are due by March 31. Badges are \$20.00. She then introduced two new Associates.

Minutes: Recording Secretary, Nancy Jarvis, noted that the Minutes of the December 8, 2021 meeting were distributed to membership via The Rumbler. There were no corrections, therefore, upon motion made and seconded, the Minutes were approved as distributed.

Treasurer: Treasurer Jacie Peters commented on today’s attendance, noting that there were reservations for a record 71, with 29 guests. However, an additional 13 arrived with no reservations, which has created a seating problem. It is extremely important to RSVP to meetings. COD Casino has been very accommodating, but it is important to have an exact count.

Treasurer Peters reported that the Executive Board met, reviewed and approved the proposed 2022 budget (copy attached to original Minutes) which was distributed to the membership prior to this meeting (hard copies available throughout the room). She discussed it in detail and noted that she and the Board welcomed any thoughts or comments. The final proposal will be voted upon at the February meeting. She noted the current checkbook account balance was very positive and we are going to be able to distribute significant funds to Republican candidates this next election.

St. Patrick’s Dinner: Treasurer/Chair-St. Patrick’s Dinner Peters reported that the St. Patrick’s Dinner this year will be on Sunday, March 13th and will be at the Carson Valley Inn. Tickets are \$45 and she urged everyone to attend and invite others. This is the only

major fundraiser that SNRW does, and the funds go toward supporting our Republican candidates.

Corresponding Secretary: Jan Muzzy reported that she will be doing correspondence for the club this year and will be sending thank you notes to speakers, donors, and others as needed.

Old Business: President Condron reminded members that the NvFRW Northern Leadership Conference will be held on Saturday, January 15th at the Governor's Mansion. All are invited to attend."

New Business: President Sondra was pleased to announce that all Committee Chairs for 2022 have been filled. SNRW President Condron and DCRW President Robertson will be meeting this afternoon with Douglas County Clerk-Treasurer Amy Burgans to discuss how the Republican women's clubs can be involved in the upcoming election. SNRW, DCRW and DCRCC are looking into a possible candidate's forum after the filing is completed.

DCRCC: Jim McKalip, Chair of the Douglas County Republican Central Committee reported that the committee is working hard on the Lincoln/Reagan Dinner, which will be on February 18th. Tickets are \$70.00 for dinner and an additional \$40.00 for the reception and book. "He also reported that this year rather than two precinct meetings, there will be only one event/one day; the precinct meeting in the morning and the county convention in the afternoon. More to follow at a later date.

Announcement: President Sondra was excited to announce that at today's meeting SNRW collected \$375.00 in donations to WAVE, Welcome All Veterans Everywhere.

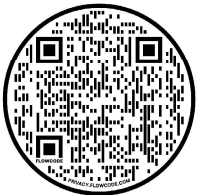

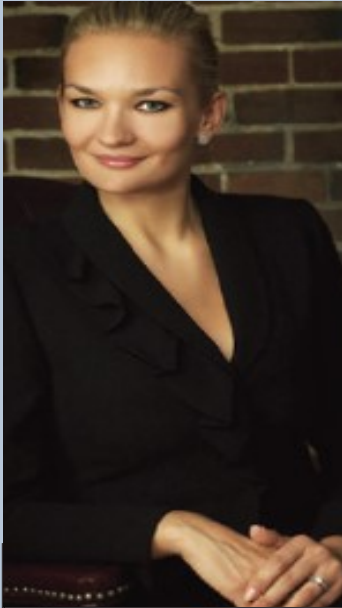

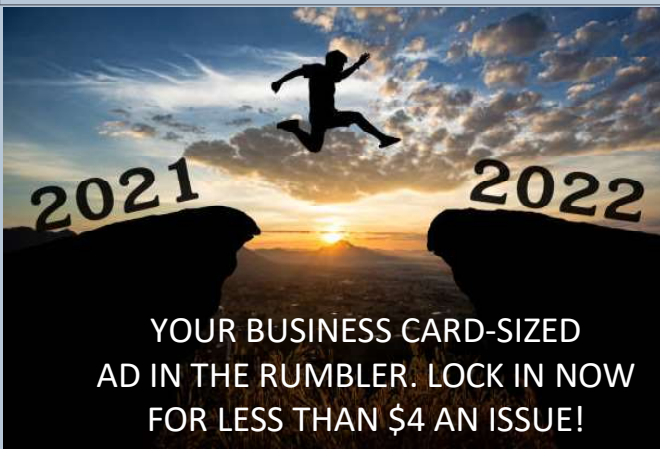
