

Democrats versus Republicans on Tax Issues

The 2020 Democratic Party Platform

The Democratic Party Platform clearly states that President Trump's tax system was "rigged against the American people by big corporations and their lobbyists, and by Republicans who dole out tax cuts to their biggest donors while leaving working families to struggle". Their position is that President Trump's tax and trade policies encouraged corporations to ship jobs overseas in order to avoid paying their share of taxes. Their Platform states that they will make the wealthy pay their fair share in taxes, raise corporate tax rates, and raise estate taxes back to the historical norm. They want to make sure that investors pay the same tax rates as workers.

The 2016 Republican Platform

The Republican Platform was not revised in 2020 but their position on taxation has been consistent over the last several years.

Whenever tax rates penalize thrift or discourage investments, they must be lowered. Wherever current provisions of the code are disincentives for economic growth, they must be changed. We will not divide the American people into winners and losers. We will eliminate as many special interest provisions and loopholes as possible and curb corporate welfare, especially where their erosion of the tax base has created pressure for higher taxes.

The Democrats have clearly demonized President Trump throughout their Platform and plan to make their tax system unfair to all Americans.

What is Patriot Day?

By a joint resolution approved December 18, 2001 (Public Law 107-89), the Congress has designated September 11 of each year as "Patriot Day."



President Trump further declared the following: *On September 11 in observance of Patriot Day, the flag of the United States of America should be displayed on the homes of Americans, the White House and all United States government buildings. The flag should be flown at half-staff as a mark of respect to those who died on September 11, 2001.*

Many people choose to observe a moment of silence at 8:46 a.m. (E.S.T.). This marks the time that the first plane flew into the World Trade Center. Some communities, particularly in the areas directly affected by the attacks, hold special church services or prayer meetings. People who personally experienced the events in 2001 or lost loved ones in them, may lay flowers or visit memorials.

Message from Shirley Brooks-Jones

Thanks a million for inviting me to put something together for you. Just know that I'll be thinking of all of you on September 12. Hard telling what I'll be doing that day. One thing for certain--those Newfoundlanders will keep me busy! Hugs and love, Shirley



It seems impossible that nearly three years have elapsed since I had the privilege and honor of speaking at the 2018 Sierra Nevada Republican Women annual dinner commemorating 9/11. During the intervening years, it has been extremely difficult to fully comprehend the many ways our world has been torn apart, but I would like to share a brief update on a few things that have occurred since I talked with you about my 9/11 experiences in Newfoundland.

2019 marked my 29th return to Newfoundland (lovingly called "The Rock") when I presented scholarships to the 17th graduating class of Lewisporte Collegiate (high school) since the first scholarships were presented in 2002. As I left The Rock, my thoughts were of Trip #30 coming up in 2020. But that was not to be! The pan-

demic prevented travel in 2020 and 2021; however, the graduation ceremonies and scholarship presentations were done virtually, and there have now been 341 recipients of the Lewisporte Area Flight 15 Scholarship established by passengers and crew of Delta Flight 15 as well as many friends around the world. The kids have gone on to accomplish marvelous things in their communities, and I am so proud of them! One young woman from the first class in 2002 went on to obtain two Masters and her Medical degree and was recently named "chief of staff" of her local hospital. A young man from the Class of 2019 is majoring in Marine Engineering and is currently doing a 7-week internship aboard one of Canada's steamship lines.

Great news: I've just been able to make reservations to fly to Newfoundland for the 20th anniversary

of 9/11. After a talk to the Columbus Metropolitan Club at noon on September 8, I'll go directly to the airport for a flight to Toronto, change planes to Halifax where there will be a horrendously long layover before flying to Gander, arriving there mid-afternoon on the 9th. Return flights will be similar—leaving Gander for Halifax mid-afternoon on the 17th, another long, long layover in Halifax

until the flight to Toronto at 5:25 a.m. on the 18th. Flight from Toronto will get me back in Columbus mid-morning the next day. I know I will be weary, but will be truly happy to have been able to once again set foot on The Rock!

I'm so happy that the hit Broadway musical *Come From Away* will once again be

playing to audiences all across North America. Its performance in Columbus, Ohio had to be postponed in 2020 but is now scheduled for February 8-13, 2022 and I am delighted to learn that the Executive Producer and James Earl Jones II who portrays me in the musical, will be in town. Will be lots of fun catching up with them.

I shall be thinking of all of you on September 12 as you gather once again to commemorate 9/11. My thanks to all of you, and my love to you as well.

Finally—a saying by the Dalai Lama: "BE KIND whenever possible." It is ALWAYS possible.


As we commemorate 9/11 at our Patriot Dinner this year, I am passing along Shirley Brooks-Jones' recommendation that you take a look at Jim DeFede's just published update describing the events that occurred on 9/11 in Gander, Newfoundland. Those of you who attended our 9/11 Commemorative Dinner in 2018 will recall that Shirley was our guest speaker.

The original version of this book, "The Day the World Came to Town," was recommended to you following Shirley's presentation. This edition includes more information about how the residents of Gander touched the lives of the thousands of passengers forced to land in Gander on 9/11. These stranded passengers, including Shirley, were treated with an overwhelming display of friendship and goodwill.

The update also describes some friendships that developed between these passengers and residents of Gander, friendships that have lasted for 20 years. Scholarship funds have been provided to the children of Gander, and securing funding for the scholarships has become a significant part of Shirley's life. Since September 11, 2002, she has returned to Newfoundland every year (2020 excepted) to present scholarship awards.

Take Shirley up on her reading recommendation. You most likely sure could use a positive story at this time.

News from the 2nd Vice President/Membership Chair


Hello SNRW Members and Associates,

Ramping Up for Nevada Day 2021

Whether native-born or transplanted, Nevada residents share a special kind of pride. So beloved is Nevada that it is one of the only states to celebrate its Admission into the Union.

This year will be our 157th birthday, and 2021 also marks 83 years since the Nevada Day Celebration moved to the State Capitol. Except for last year, a large downtown parade has taken place along Carson Street, beginning at the intersection of William Street and N. Carson and ending at Stewart Street and South Carson.

Since we were unable to celebrate much of anything last year, plans are to make it a big event this year. The theme, "Historic Moments in Nevada" was chosen to focus on moments throughout history that helped to shape and define this state. From the day Nevada was admitted to the Union, October 31, 1864 (*during the Civil War*), to today, here are some periods in time during the 157 years of statehood that tend to set us apart from the other 49. The Nevada Day Committee will reflect on some of these happenings in our history. Highlighted will be moments from the historic Gold and Silver Boom in the Comstock, legalized gaming and prostitution, quickie divorces, Women's Suffrage, UFO sightings (*and possible landings*), and even a more recent decision to legalize Cannabis.

The people who make this event happen are part of a small nonprofit organization known as *Nevada Day Inc.* They keep this tradition alive despite facing many challenges such as rising costs, volunteers coming and going, and tightening



rules and regulations. Yet they never tire of seeing the pride and joy of fellow Nevadans as we celebrate our state's birthday.

This year's event promises to feature some extra energy to make up for missing 2020.






